

**BRWP Annual Members Meeting
Hancock County Agricultural Bldg.
October 21, 2010**

Board of Directors present: Connour, Loerhke, Kozlowski, Benroth, Allen, Schroeder, Lehman, and Brugeman.

Kozlowski called the meeting to order at 7:00 p.m.

Kozlowski welcomed the audience. Kozlowski noted that this is the fifth anniversary of our organization. A reminiscence of the major steps to 2010 was presented along with an assessment of where we are today, a proud volunteer group dedicated to and ready to implement a number of projects to improve the water quality in the Blanchard Valley. The new PR brochure "A Citizen's Guide to Measuring the Value of the Blanchard River" was presented as our next step to reaching a broader audience.

Kozlowski introduced our two speakers: Linda Merchant-Masonbrink - OEPA Program Coordinator reviewed the science of algae blooms that have been plaguing Lake Erie and now inland lakes and ponds over the last few years. The 2010 toxic algae bloom is particularly important for our region of NW Ohio. The toxic "algae" is actually a bacterial growth that occurs at the same time and often appears the same. These bacteria release a cyano toxin during its life cycle.

Melinda Huntley- OSU Sea Grant Extension Officer reviewed the economic value of tourism in Ohio concentrating on the values in the Lake Erie region and the damage caused to the Lake St. Mary's region this year.

A question and answer period followed the presentations.

Kozlowski read and asked for an approval of the minutes as submitted from the 2009 Annual Meeting. Minutes approved.

Benroth presented a summary of the finances for 2010 and reported we have a cash balance of \$25,283.18 as of September 31, 2010.

Kozlowski presented the Nominating Committee slate of candidates for election to the 2011 to 2013 term for Board of Directors. No nominations were made from the floor and the slate was elected by acclamation. Those elected were: Robert Antibus-Riley Creek, Bob Connour-Eagle Creek, and Tim Brugeman-At Large #2

Martin presents a slide show that reviewed the accomplishments of 2010 and the goals for 2011 (See next page).

Nancy Benroth received the "2011 FRIEND OF THE RIVER" award for her outstanding work over the five year period of our existence. Nancy served as out treasurer for all 5 years and as secretary for the last three years.
